




2-A. Codex Enhancements

UPDATES - AFTER 55 YEARS!

CCPR schedule, nomination, label is now online

- Procedures, funding, harmonization, efficiencies



Six e-Working Groups(eWG) going on at CCPR:

- New Compound Reviews: Canada & Costa Rica lead Joint National Reviews + JMPR/CCPR
- 2. New Use Reviews: US/IR-4/CLI proposing APEC-like procedure
- 3. <u>Periodic Reviews</u>: Chile/Kenya/C.Rica to prevent cancel Codex-MRL if any active use
- 4. National Registration <u>database</u> at Codex: to prioritize periodic reviews and when to cancel (no active registration)
- 5. Analytical method for enforcement review to include MS/MS-characterization
- 6. Guideline for <u>Biopesticides and low-toxicity</u> compounds (Chile/India) has proposed process for tolerance exemption



21 economies from the Pacific may have an ideal system for The Global MRL

APEC Food Safety Cooperation Forum Sub-Committee on Standards and Conformance, July | 2016 IMPORT MRL GUIDELINE FOR PESTICIDES A guideline on possible approaches to achieve alignment of international MRLs

- Accepts MRL from <u>export</u> country (based on agency's review report, no data), if dietary risk is acceptable to <u>import</u> country
 - This implies significant save of time and resources, plus <u>SAME</u> MRL
 - Implemented in Australia, US, partially in Canada, Korea
 - Pending pilot across all countries (phase IV)



2-D. Missing MRL

EXPONENTIAL INCREASE IS NOT SUSTAINABLE!

Missing MRLs occurs when:

- MRL has not been established for the crop or crop-grouping, that may be different crop groupings in the importing countries or;
- MRL has not been established for the crop or cropgrouping/pesticide combination and instead a default MRL (typically 0.01 mg/kg is applied).
- Import market does not have a formal regulatory framework to establish MRLs or to recognize exporting country's MRL;

- 15 countries & industry
- WTO SPS Ministerial Agreements
- WTO paper on MRLs to help address missing MRLs

Updates from Minor Use Initiatives, WTO SPS, Codex, Industry



3. Solutions for Missing MRL

Existing Precedents – all countries accept traces in trade if lower that analytical LOQ (0.01 ppm) → risk is negligible

Agency	Pros	Cons
Codex	- MRL adopted by 70 countries, possibly all 189	Shortest list of MRL (<5,000)
EU	EU harmonized MRLDefault MRL	88% default MRL Trigger illegal uses
Japan	2006 PSL (highest existing MRL)	Heavy workload periodic reviews
APEC	22 countries mutually accepting MRL, if risk OK	Implementation still in progress
Australia	MRL for "all other foods, except animal commodities"Monitoring accepted <0.1 ppm	Contribution to risk < 20%
China	Applied Codex, MRL export country, or LOQ	IT regulation is pending



The ONE MRL Concept

ONE GLOBAL MRL – THE IDEAL SYSTEM

- First country to approve a new use sets MRL
 - Notify WTO SPS & CCPR for JMPR peer-review, global risk & posting MRL
- All other countries (189) to adopt Codex MRL (same, lower GAP)
 - Submit for increased MRL, in case of increased GAP

Benefits

- Harmonized MRL (domino effect)
- No IT needed (or very few)
- Faster introduction of new uses
- Cost optimization for avoiding re-work
- Less, or no trade-irritants

1st national · Reviews new data agency

- Sets MRL
- Notifies WTO SPS + CCPR

Codex


- Peer-review agency report
- Risk for WHO global diets
- Approves & lists MRL
- Periodic reviews of MRL


All other Countries • Set IVIRL 101 III Cleased use • Notify WTO SPS + CCPR

- Adopt Codex, or
- Set MRL for increased use

1. Support true harmonization 2. KEEP RUNNING THE MRL MAZE! (e.g ONE MRL)


